BUILDING RENTAL RULES

- 1) Access to building for event set up will be allowed 3 hours prior to event;
- 2) Absolutely NO SMOKING anywhere in building, all smoking is to be done outside and cigarettes to be disposed of in appropriate receptacles.
- 3) Building must be cleaned and returned in the condition it was found. <u>Tables are NOT to be</u> <u>moved</u>, and all chairs are to be put back in the chair holder
- 4) Deposit will be returned after seven (7) calendar days from the date of the event if building is returned in the same condition received, and no damage to building or equipment was found.
- 5) Floors are to be swept and mopped, bathrooms are to be cleaned and left in the condition received, trash is too be removed from the building and placed in outside dumpsters or removed from the property.

- 6) ABC licenses are the responsibility of the rental party. This license must be in the name of the party who is named on this rental agreement. This person must be on premises at all times during the event.
- 7) All activities and the consumption and/or sale of alcoholic beverages MUST be discontinued on or before 12:00 am midnight
- 8) Cancellation of a reserved event must be made 30 days prior to event date to receive a refund of the deposit. Anything less than 30 days renter will forfeit the entire amount of the deposit.

- The Remington Vol. Fire and Rescue Department (RVFRD) is not responsible for any "Acts of God" which may cause cancellation, interruption, or disruptions of any scheduled event.
- The RVFRD cannot and will not be held responsible for any criminal and/or civil liabilities that result in actions by you or anyone at your event
